Master National 2020

As many of you know, the Master National is scheduled to run at CMRC and the surrounding areas from September 26 through October 4. This event is the world's largest competitive retriever event with expectations of 800-900 dogs competing over 8 days in 6-7 flights with 6 series.

The Greater Minnesota Hunt Test Association is the host entity. The GMHTA is asking its member clubs to support the event by providing workers to work in the field in the "dead bird" stations loading wingers and planting blinds. If working in the field is not an option, they also need workers to assemble lunches daily for the judges and workers of the event. The Master National Retriever Club pays these volunteers by making a "donation" to the home club of each worker at the rate of \$120 a day for a full day's work. This is an outstanding opportunity for CMRC to earn considerable revenue for our club!

If you are interested and willing to volunteer for a day or multiple days of the event, please contact Gordie Schlichting. Volunteer workers will be assigned to specific flights and locations with advance communications prior to the event. Our plan is to have all assignments filled and scheduled well in advance of the start of the event.
