Message from Gordie Schlichting, CMRC President

Good day CMRC!

A week ago, we were basking in temperatures in the 70s and even 80s. The snow had quickly melted, and we all were excited to finally see Spring had arrived. And then the weekend came. First the onslaught of rain and wind on Saturday during our Super Singles Event made for less than a perfect day, but we all had fun, 70+ dogs were entered, and we all enjoyed the event. Then Sunday came along. It was as if Old Man Winter had been "triple-dog-dared" by all the other seasons of the year that he didn't have it in him to make us miserable one last time on April 16. Old Man Winter turned to them and said "Oh yeah? Hold My Beer!" and let us all have it. 4-6 inches of wet heavy snow kind of slowed us down. But our final winter informal trial of the season continued, and although we had fewer than average entries, we still had fun.

Now don't nobody go jinxing things and start talking about how nice the weather is, or how long the winter has been or nothing like that to scare away Spring once again.

As I said in last month's message, I want to remind you once again of a few things.

First, we have our Spring Licensed Field Trial May 25-28. And our June Licensed Hunt Test is June 16-18. It takes many people to make these events come off without a hitch. We have excellent chairpersons and committee members that work tirelessly throughout the entire year preparing and planning for these events. But the five-person committee for each event cannot do it all alone. It takes on average 7-8 people to run each stake of a hunt test or field trial. We need people to throw and shoot the live birds, to throw the dead birds, to plant the blinds, to marshal the event and to manage the birds at the line. When we hold events that have 4-6 individual stakes, you see how that number grows. If you are a member of the CMRC we expect you to come and help when you can. Don't worry that perhaps you have never done that job before, someone will teach you. You cannot mess it up that badly. In all my years or being involved with retriever events, I have hardly ever seen someone fired from their job. And do the chairs and committee the favor of volunteering BEFORE they have to call you. I am absolutely certain they will appreciate the call. And if you do not get a chance to call them first, when they do call, please do your best to find some time to come and help. You will have great fun. You will learn a lot from watching the dogs run and the handlers handle.

Second, as we begin to use the grounds increasingly for training now that our snow is gone, please be careful with how we treat the grounds. Driving a few pickups off-road across a field can really tear up the grounds and make ruts we have to repair. If the fields are wet and mushy, stay on the roads. Find a way to get your training set-up in that does not require digging up the fields.

I also want to take a moment to thank a few important individuals that have made our winter events successful. First Greg Murtha for not only his tireless efforts as our club secretary, but also for being a ramrod on our winter informal trial efforts. Greg secures and schedules the judges for all the stakes for each month, even the months we have cancelled, Greg had judges lined up and ready to go. Next is Mike Verdon. Mike is a member of our board and brings his perspective to our board and club discussions, but he also beats me to the clubhouse every month to have the judges' book and sign-up sheets ready to go for the informal registration and gets the furnace heated up and the coffeepot going. Doug Braun deserves all of our appreciation. Doug is another board member, but beyond his work on the board, Doug is at the club almost every day and is constantly removing some brush, plowing some snow, putting away birds, getting birds pulled out for the Informals, and generally watching over the grounds. And finally, I want to express a sincere appreciation for Chad and Sharon Sweep for spearheading and managing the Super Singles event for the third straight year. It was Chad's idea a few years back to start the event as a "new to us" event to add another profitable and fun event to our calendar. Chad and Sharon have done everything for the event from securing the judges and throwers, soliciting donations for prizes as well as for the silent auction and raffle. The Super Singles event is quite profitable and a lot of fun. Chad and Sharon deserve a huge thank you from all of us for all their work.

Finally, you will hopefully begin seeing some changes around the yard at the club. We are hoping that around June 1st we will begin the remodeling process of our clubhouse. The building committee and board are reviewing bids and estimates at this very moment that I am writing this message. We will be reaching out to all of our club members with a fundraising campaign soon. If all goes well, we may have most of the work completed on the remodel by the end of July perhaps. I am personally excited to see this project come to fruition.

Like you I look very forward to consistent warmer weather and to being out in the field training, trialing, and testing our retrievers and spending time with our fellow enthusiasts. Have a great spring! See you at an event this spring and summer!
