It's that time of the year again folks for our CMRC Licensed AKC Hunt Test. This year's event is Friday, June 13 through Sunday, June 15. We will be having a Double Master, Double Senior and Double Junior Event. If you are interested in running your dog in the event you can look it up on Entry Express and get the complete judges' panel and view the entire premium with the schedule and so forth.

As with any event, the work doesn't get done by itself. It takes a great many people to have a successful event. Last year this hunt test had an entry of 300 dogs for the three days. That's a lot of dogs, but it also means a lot of profit for our club.

I am in need of marshals, dead bird throwers, live bird throwers and shooters, and kitchen support. As always, we have some positions ideal for youth such as shagging birds at the line or planting blinds in the field. If the youth are 16 years of age and have a valid gun safety certificate, we can use them to throw dead birds. These are paying jobs for our youth.
