Gordie Schlichting addressed the possibility of having the 2020 Master National at CMRC. The committee has met to begin planning and creating a proposal to hold the event at CMRC and nearby properties with the potential of having 1000 dogs entered. GMHTA (Greater Minnesota Hunt Test Association) will be involved with the event which would use the grounds at CMRC, BRG, Stawski's, Farmer's, Landecker's and Hanson's.

It will be held in September starting the week after HCARC's fall trial. The testing of dogs lasts 8 days and the judges arrive a week earlier to set up the tests from Saturday to Thursday. The grounds will be tied up for 2 weeks and not available for training or airing dogs. We should know in February if the bid for the event is accepted.

The clubs will have the opportunity to realize profits which from the Training book, food and clothing sales. There is the potential of making \$50,000. The profits will be divided among the clubs based upon which club does the most work for the event.

The Informal trials have begun and are held on the third Sunday of the month. Entry fees are \$15 for the Open, Qualifying, Hunters, Jr Hunters and Derby. The Puppy stake remains at \$10. Sign up begins at 8:30 and the event begins at 9:00 am.
